MINUTES

1. Call meeting to order

President John Julian called the meeting to order at 10:07 am

2. Establish a quorum

3. Discussion and possible action on approval of minutes of July 22, 2023 Board meeting

Motion was made by Bill Stoner to approve the minutes of July 22, 2023 Board meeting. The motion was seconded by Terry Lowe. No discussion was heard and motion passed unanimously.

4. Notification of resignation of C&D representative to Board of Directors

President Julian notified the Board of the resignation of Eric McElroy as chapter representative on the Board of Directors of the Panhandle/ South Plains Chapter.

5. Discussion and possible action on TGWA logo

Motion was made by Amy Bush to accept Option 1 (block TGWA) as the new Association logo. The motion was seconded by Vickie Ross. Discussion was had that Option 3 and Option 1 were both favorable and that. A primary and secondary logo should be considered. Amy Bush withdrew her motion to accept Option 1 as the logo. The withdrawal was approved unanimously.

Bob Hill made the motion to accept Option 3 as the primary logo, with consideration of altering the water well to be more prominent and to make Option 1 a secondary logo. Motion was seconded by Vickie Ross. Motion passed unanimously.

6. Discussion and possible action on Financial Reports

Finance chair, Mike Pyburn gave a report on financial standing of the Association. He reviewed the Statement of Activity, Profit & Loss (P&L) Statement compared to Budget, and P&L compared to previous Fiscal Year.

7. Discussion and possible action on request from the Membership Committee for funds.

A request from the membership committee to spend funds on promotional products was entertained. A recommendation from the finance committee was to allow for the purchase of table cloth, exhibitor booth backdrop, and rack cards. Vote was unanimous to accept the recommendation of the finance committee.



8. Discussion and possible action on the request for sponsorship from the American Groundwater Trust

Executive Director received a request to sponsor an upcoming children's book from AGWT. Sponsorship would be for \$2000 to assist with publishing and distributing. No action was taken.

Executive Committee met on October 11, 2023 to 1) allow ED permission to excute a contract with Embassy Suites San Marcos for 2026 & 2027 Annual Conventions, and 2) directed ED to conduct survey vote of the logo options from the membership.

- Convention (Bob Hill) Committee made the recommendation to the Executive Committee to go to 2 years in San Marco as home base for annual Conventions and a third year in a satellite location. Wrapping up pre-planning of CE topics and schedule tweaking.
- Continuing Education (Amy Bush) Provided information to ED to plan for new classes for the Convention. Should have more than 3 new classes for 2024 Annual Convention.
- Fountainhead (Bobby Bazan) Reminder to board and members that if they have topics they would like to see/share in the fountainhead to pass those along to ED.
- Finance/Legislative (Mike Pyburn) Legislative committee needs to meet to discuss TDLR rules recommendations.
